## Group Play Liability Waiver

I,	, hereby certify that my pet is in good health and has not been ill with any
co	ommunicable condition in the last 10 days. I further certify that my pet has not harmed or shown aggressive or
th	reatening behavior towards any person or any other dog.

## I have read and understand the following:

- I recognize that there is an inherent risk of injury, illness or death in any environment associated with numerous pets. I also recognize that such risks include, without limitation:
  - o Injuries such as broken nails, sore paw pads, puncture wounds, abrasions and cuts, etc.
  - o Transfer of communicable illness (i.e. Kennel Cough, or Bordetella)
  - o Illness or death resulting from stress, altercations, rough play, or contagious illness.
- I understand that I am solely responsible for harm or injury caused by my pet while they are participating in Group Play at Red Bluff Pet Resort, including injury to humans or animals, and I expressly agree to be held responsible for medical costs due to injuries caused by my pet.
- I am fully aware of Group Play and Temperament Testing fees and agree to pay in full as outlined.
- I understand and agree that in admitting my pet to Red Bluff Pet Resort for Group Play, the facility's staff has relied on my representation that my pet is in good health and has not harmed or shown aggressive or threatening behavior toward any person or any other dog.
- For safety reasons, I understand that if my dog displays aggressive behavior that they will be confined to an enclosure for the remainder of their stay at Group Play and not allowed to return for future sessions.
- I further understand and agree that Red Bluff Pet Resort and their staff will use reasonable precautions against injury, illness, escape, or death of pets while in our care. Red Bluff Pet Resort will not be held liable for any problems that develop, provided reasonable care and precautions were followed, while your pet is in Red Bluff Pet Resort's care. I hereby release them of any liability of any kind whatsoever arising from my pet's attendance and participation in Group Play.
- I understand that pets can sometimes receive minor cuts, scrapes, and scratches during Group Play and any problems that develop with my pet will be treated as Red Bluff Pet Resort staff sees fit based on their professional experience. I assume full financial responsibility for any and all expenses involved.
- I understand that if my pet is under 7 months old and is not spayed or neutered that it is at my discretion to let them participate in Group Play at Red Bluff Pet Resort. I further release Red Bluff Pet Resort and its staff from any responsibility regarding pregnancies or breeding that may occur while at our facility.
- I hereby waive and release Red Bluff Pet Resort and its staff from all liability for any injury to myself resulting from the action of any dog (including my own) and I expressly assume the risk of any such damage or injury while my pet is attending Group Play.
- Red bluff Pet Resort may use pictures of my pet for publicity or promotional purposes without liability or obligation of
  any kind to me; however, no information or pictures can be sold or shared with a third party without additional
  consent.

I certify that I have made full disclosure and read and understand the policies of Red Bluff Pet Resort's Group Play as set forth in Group Play Policies and that I have read and understand the conditions and statements of this agreement. I also accept the risks associated with Group Play and affirm the terms of this agreement each time my pet(s) enter Red Bluff Pet Resort for Group Play activities.
